MINUTES

Minutes of the General meeting of WASFR Inc. held at the Cambridge Bowling Club, Howtree Place, Floreat, on Friday **10 OCTOBER 2025.**

The President opened the meeting at 10.05am and welcomed the 24 members and the 22 visitors.

CONFIRMATION OF MINUTES: Moved I, Moller, and seconded by R. Wyatt, that the Minutes of the meeting held on 12 September 2025 be accepted as a true record. Carried.

BUSINESS ARISING:

Investment Group: Nothing to report at this stage. P. Farr will continue as the facilitator for the foreseeable future. A general comment was made in regard to solar panels and the recent fire that was caused by a faulty installation - not a common problem.

WA Seniors Peak Body/Advocare: It now appears that the earlier suggestion that Advocare would establish a *Seniors Reference Group* and a *Seniors Sector Leaders Group* has been dropped. COTA WA has been appointed to assist Advocare with Secretarial duties and expressions of interest have been invited for a position on a *Seniors Peak Consumer Reference Group*. Nominations close on 10 October so it may be a few weeks before any further information is available.

Following on from the meeting with the WA Minister for Seniors (Simone McGurk) on 8th September we received a response saying that the matter of exemption from Stamp Duty for Seniors when they downsize has been referred to the WA Treasurer. The response was "This remains a vital source of revenue for the State, helping to fund essential services such as health, education, law and order, and transport. The Government must balance the desire to reduce state taxes, with the need to meet growing community demand for these services. Overall, it is important for us to ensure the tax system remains fair and equitable for all taxpayers." In other words - no change.

We expect to have the WA Minister for Seniors as a guest speaker at one of our monthly meetings some time next year.

Seniors Dental Benefit Scheme: The President referred to the letters sent to 3 Federal Ministers in August and reiterated that it was a good sign that retiree organisations, when necessary, are able to combine their efforts in order to achieve a common goal. No responses yet from these 3 Ministers.

FINANCE: The Treasurer invited members to look at the monthly financial statement on the back of today's Agenda. Funds available as at 3rd October were \$6,624.04 with no outstanding accounts. No questions from members.

Other: The Secretary reminded members that next month there will be no formal meeting. The guest speaker will commence his presentation immediately after the President opens the meeting. When the speaker has finished (around 11am ??) everyone will be encouraged to "have a cuppa" and enjoy the savoury foods that will be on the table. There is a cost of \$10 for members (\$15 for visitors). The President said that an email received that morning indicated that unrealised capital gains would be removed from the proposed legislation surrounding the Division 296 tax - also that the levels would be indexed.

After the morning tea break the President welcomed Danielle Johnston and Anita Clayton to talk about issues revolving around Arthritis and Osteoporosis. Anita is a retired nurse and has worked in remote areas such as Halls Creek. She has had 28 years at the Perth Chest Clinic with the last 10 years in charge of the WA nursing services for Tuberculosis and Migrant Health. When the clinics moved to new premises the building was named "The Anita Clayton Centre" in her honour.

Danielle has just taken on the role of Health Promotion Co-ordinator with Arthritis and Osteoporosis WA (AOWA) and was present as a back-up for Anita who was the main speaker. There was an informative power-point presentation that was well received. Many questions from members and the 22 visitors. At the conclusion of the talk the President made a small presentation to Anita thanking her for an interesting and informative presentation.
